Subject:- Norms for loss of substantial portion of land caused by change of course
of rivers.

The Governor of Haryana is pleased to fix Norms for loss of substantial
portion of land caused by change of course of rivers @ Rs.12,000/-per acre.

2. Out of the said amount of Rs.12,000/-, an amount of Rs.6000/-will be met
from Calamity Relief fund and Rs.6000/-will be met from State budget.
3. The relief will be paid to only such farmers who have been doing
cultivation on the land lossed due to change of course of rivers for the past two years. The
relief would be provided to only small and marginal farmers and normal soil erosion
caused due to flow of river is not covered under this scheme.
4. The above said norms of relief will be applicable to the losses caused by
floods, 2010 onwards.

Subject:- Norms of relief to be provided to farmers whose land has been rendered uncultivable due to standing flood water.

The Governor of Haryana is pleased to order that relief @ Rs.3,500/-per acre will be paid to such farmers whose land has been rendered uncultivable due to standing flood water during Rabi Season, 2010 subject to the following conditions:-

- i) Relief would be payable to such farmers only whose land could not be cleared of flood water upto 30-11-2010.
 - ii) Relief would be admissible for such land only on which the two last rabi crops could not be sown due to standing water.
 - iii) Survey for verifying such land be got conducted by deputing a team of officers/officials.
2. The whole amount of Rs. 3,500/- will be met from State budget.
 3. The above said norms of relief will be applicable to the losses caused by floods, 2010 only and this relief should not be taken as precedent in coming times.
 4. They are requested to send proposals through Divisional Commissioners to grant relief to the eligible farmers immediately.
 5. This issues with the concurrence of Finance Department conveyed vide their U.O.No.1/15/2009-2FG-II/1092, dated 17-6-2011.





